2.2) Watermark on the Flexi@Home system

A watermark showing the student's full name and phone number will be displayed on the screen when the courses are viewed.

This watermark will only be displayed on screen but will NOT be printed on the course notes.

The student's full HKID is required for enrolment but will NOT be displayed on screen.

2.3) Number of viewing hours
