From then on, the student can only access the system using the same device and location. Only desktop or laptop computers are allowed access to the Flexi@Home system. Mobile phones and tablets cannot be used to access the Flexi@Home system. Only one desktop or laptop computer can access the Flexi@Home system using the same log-in ID and password at any time.

#### 1.2 Watermark on the Flexi@Home system

A watermark showing the student's full name and phone number will be displayed on the screen when the courses are viewed. This watermark will only be displayed on screen but will NOT be printed on the course notes. The student's full HKID is required for enrolment but will NOT be displayed on screen.

#### **1.3 Number of viewing hours**
